Communication & Scheduling

Call or text 206-938-7627 to reach me the most quickly. You may also use my HIPAA compliant email (Michelle@CalmerMom.Solutions), however I only check email once per day. Please don't use email for schedule changes with less than a week's notice.

Appointments, Payment, Cancellations & No-shows:

Fee: \$1625 per month, charged as an automatic payment on the 1st of each month. If you begin sessions with me part way through the month, your first payment will be pro-rated based on the date of your first session, payable at the time of scheduling.

Fees are subject to change with 60 days advance notice.

Schedule: Weekly session (approximately 90 minutes in-person or via Zoom) with one week off each month – usually the last full week of the month. We will always confirm the schedule for the upcoming month at our last session of each month.

This consistent schedule supports dynamic change for you, the client. It also supports my professional practice as an honoring of me, so I can show up at every session, 100% present and honoring of you and your commitment to change.

Payment: Payment for each month is due on the first of each month, and will be automatically charged to your credit card on file. I don't offer discounts or sliding fee appointments, again as an honoring of the work, as an invitation for you to commit fully to your value and well-being, and as part of my commitment to fully contribute to my own well-being, my family, and Noble Steps Healing: The Calmer Mom Project.

Because sessions include a unique blend of bodywork, energy transformation and verbal coaching, this work does not fit with billing medical insurances.

Cancellations and Missed Appointments: Monthly fees are the same regardless of the number of sessions each month. Usually there will be three sessions per month, with some months including four.

If you are unable to come to your appointment, please call/text me at 206-938-7627 as soon as you know you will be unable to attend.

- If you give less than 24 hours' notice, you will be unable to reschedule the appointment and will be charged the full fee.
- If you give more than 24 hours' notice, I will make every effort to reschedule you to a Zoom session within 2 weeks of the missed appointment. Please note, even if we are unable to find a rescheduled time you are still responsible for the full monthly fee.
- At this time I do not have an appointment reminder system in place, so please set your own reminder.

Travel and Vacation Time: If you have planned travel time, we can change your in-person session to a Zoom session. Zoom sessions are generally 90 minutes, and Access Bars® and bodywork are replaced by a Symphony of Possibilities® session.
